## 6. Action Items

6a. Draft FY 2018/19 - FY 2022/23 Transportation Improvement Program (TIP): Review of the draft FY 2018/19 - FY 2022/23 TIP.

Mr. Buchwald introduced the agenda item by explaining that the TPO is required to develop a TIP annually to identify the transportation improvement projects located within the TPO area that have been prioritized and are receiving federal or state funding. Mr. Ding continued the presentation with a summary of the year-long process undertaken to develop the TIP draft under consideration. He highlighted a variety of projects included in the draft and concluded with an explanation of how the draft TIP incorporates performance targets set out by the Go2040 Long Range Transportation Plan.

# **6b.** Congestion Management Process (CMP) Major Update Phase 2: A presentation on Phase 2 of the CMP Major Update.

Mr. Buchwald explained the CMP as a way to identify areas with congestion or safety issues and address those issues using a variety of strategies that can be implemented more quickly than the typical roadway widening project. He noted that the need for a CMP major update was recognized by the FY 2016/17 – FY 2017/18 Unified Planning Work Program, as there were so few CMP projects remaining in the CMP Implementation Plan established during the previous update in 2011. Mr. Buchwald then invited Stanley Consultants, Inc. representative Linda Hess to present the CMP recommendations.

Ms. Hess provided some background information on the CMP, including a brief definition, an explanation of what both phases entailed, the objectives for the CMP, and a demarcation of the CMP network, before focusing more closely on the two phases of the report. She reviewed the Phase 1 prioritization criteria, explained the analysis conducted on the data, and then reported on the segments and intersections identified. Ms. Hess identified the strategies available for congestion mitigation before discussing the criteria and ranking process used in Phase 2. She listed each of the identified segments and intersections and summarized the proposed mitigation strategies in detail. Ms. Hess concluded by reviewing the Implementation Plan.

Mr. Smidtsrod inquired about the uses of fiber optics in roadway improvements. Ms. Hess explained that they enable the use of traffic count technology, among other things, which facilitates congestion analysis.

Mr. Love questioned how Stanley Consultants planned to mitigate the impact on persons with disabilities if the on-street parking on 2nd Street were removed as proposed. Ms. Hess explained that the elimination of on-street parking would necessitate the introduction of a shuttle bus to transport passengers from an off-site parking garage, and the bus would be equipped to accommodate persons with disabilities.

6c. Strategic Intermodal System (SIS) 2045 Cost Feasible Plan (CFP): A presentation on the draft SIS 2045 CFP.

Mr. Buchwald provided some background information for the presentation by identifying how FDOT works with local MPOs and other partners to plan for the SIS, which encompasses Florida's statewide network of high priority transportation facilities. He explained that projects representing necessary improvements to the SIS had been identified in the SIS 2045 Multimodal Unfunded Needs Plan (MMUNP), which was endorsed by the TPO Advisory Committees and Board in early 2017. The SIS CFP, as Mr. Buchwald noted, identifies the capacity projects selected from the MMUNP to receive future funding and therefore needed to be updated to reflect the new horizon of 2045. Mr. Buchwald then introduced FDOT District 4 representative Lois Bush.

Ms. Bush began by clarifying that, although the SIS comprises airports, railroads, seaports, spaceports, and transit facilities in addition to highways, only the latter was included in the draft under consideration. She outlined the SIS planning and programming process and then moved on to the 2045 CFP update, describing its developmental process, its time period and focus, and its purpose. Ms. Bush listed the projects in District 4 slated to receive funding, focusing especially on those located within Treasure Coast counties.

Mr. Love inquired about the status of the projects on the CFP, and Ms. Bush explained how the prioritization relates to project execution and funding.

Chairman Gilmore asked for clarification on the purpose of auxiliary lanes, and Ms. Bush replied that they do not add capacity, as they are outside lanes.

6d. Complete Streets Candidate Corridors Prioritization: Review of the prioritization of candidate corridors for complete street treatment.

Mr. Buchwald defined a Complete Street as one that accommodates all users regardless of age, ability, or transportation mode and noted that the current UPWP had provided for a Complete Streets Study aimed at

encouraging the development of such corridors within the TPO area. He outlined the components of the study and explained that Action Plans would be developed based on the Complete Streets Candidate Corridors Prioritization, the methodology for which had previously been adopted by the TPO Advisory Committees and Board. Mr. Buchwald then invited Mr. DeFini to present the draft prioritization. Mr. DeFini explained the criteria used for prioritizing each of the candidate corridors, employing the highest ranked corridor as an example.

Mr. Smidtsrod asked how many of the projects had already been funded. Mr. Buchwald indicated that they were still unfunded and explained the process of developing Action Plans for selected corridors to qualify them for inclusion in the LRTP, the LOPP, and eventually the TIP.

#### **BACKGROUND**

At its meeting on March 7, 2018, the St. Lucie TPO Board approved the annual allocation of \$300,000 of Surface Transportation Block Grant (STBG) funds to the organization for planning and administration in FY 2018/19 and FY 2019/20. Subsequently, the TPO Board approved the specific planning and administrative tasks and activities to be funded by this annual allocation through the adoption of the FY 2018/19 – FY 2019/20 Unified Planning Work Program (UPWP) on April 4, 2018. To facilitate this allocation of STBG Funds to the organization, the Florida Department of Transportation District 4 (FDOT) requests further confirmation that this allocation is consistent with the TPO's priorities by including it in the TPO's List of Priority Projects (LOPP).

The 2017/18 LOPP was adopted by the TPO Board on June 7, 2017, for FY 2018/19 allocations. Therefore, the 2017/18 LOPP requires an amendment to incorporate the \$300,000 allocation to the organization for planning and administration in FY 2018/19. Accordingly, the FY 2018/19 LOPP that will be reviewed and considered as a separate agenda item will incorporate the \$300,000 allocation to the organization for planning and administration in FY 2019/20.

#### **ANALYSIS**

The proposed amendment consists of adding the St. Lucie TPO and the allocation for planning and administration with a reference to the TPO's UPWP as the top-ranked project in the Master List of the 2017/18 LOPP. The

Go2040 Long Range Transportation Plan (LRTP) includes goals and objectives to improve land use and transportation decision-making through community participation and intergovernmental cooperation which the proposed amendment supports. Therefore, the proposed amendment is consistent with the Go2040 LRTP.

#### **RECOMMENDATION**

As the proposed amendment to the 2017/18 LOPP reflects the \$300,000 of funds allocated by the TPO Board to the organization for planning and administration in FY 2018/19 and the proposed amendment is consistent with the Go2040 LRTP, it is recommended that the proposed amendment be recommended for adoption by the TPO Board.

#### **BACKGROUND**

As part of the annual development of the St. Lucie TPO's Transportation Improvement Program (TIP), the LOPP is developed for submittal to the Florida Department of Transportation District 4 (FDOT) for the allocation of funding to projects that are or will be programmed in the TIP. The projects identified in the LOPP subsequently are funded and included in the FDOT Work Program to the maximum extent feasible. The St. Lucie TPO's TIP for FY 2019/20 – FY 2023/24 then will be developed based on the LOPP and the FDOT Work Program.

To assist in developing the LOPP, an Informal Priority Projects Meeting was conducted with FDOT and local agency staffs on May 22nd to receive the latest information on the TPO Priority Projects. The LOPP is required to be submitted to FDOT by October 1st, and the TPO Advisory Committees are requested to review it, provide input, and develop recommendations for the TPO Board regarding its adoption.

### <u>ANALYSIS</u>

The draft 2018/19 LOPP is attached. Significant changes from the 2017/18 LOPP, which also is attached, include the removals from the Master List of the I-95 Interchange at St. Lucie West Boulevard Project and the Kings Highway from the I-95 Overpass to St. Lucie Boulevard Project because they are programmed for construction. In addition, the status and estimated costs of the remaining projects in the Master List were updated as

appropriate. All of the projects in the Master List originate from the Go2040 Long Range Transportation Plan (LRTP).

The Congestion Management Process (CMP) List was replaced by the Implementation Plan of the CMP Major Update that was adopted by the TPO Board on June 6th.

The Transit List was revised to de-prioritize the Treasure Coast Transit Center and add regional bus service to West Palm Beach, on-demand flex service to augment Route 6 of the fixed bus service, and to expand the Community Bike Share Program. All of the projects/services in the Transit List originate from the FY 2014/15 - FY 2023/24 Transit Development Plan (TDP) Major Update or subsequent annual updates.

The Transportation Alternatives (TA) List was revised to reflect the results of the 2018 TA grant cycle which prioritized the Curtis Street and Alcantarra Boulevard Sidewalk Projects for TA Program grant funding. All of the projects in the TA List originate from the Go2040 LRTP.

#### **RECOMMENDATION**

Because the projects in the 2018/19 LOPP originate from the plans or programs of the St. Lucie TPO and are prioritized in accordance with adopted prioritization methodologies, it is recommended that the draft 2018/19 LOPP be recommended for adoption by the TPO Board.

SUBJECT: St. Lucie Walk-Bike Network (WBN) Update

#### **BACKGROUND**

A Pedestrian Facility Inventory Program Update was presented to the TPO advisory committees in January of 2015. This inventory was renamed the St. Lucie WBN and adopted as part of the Go2040 Long Range Transportation Plan in February of 2016.

Since then, a significant number of pedestrian and bicycle facilities have been constructed in the TPO's area, and agencies have added other facilities to the TPO's List of Priority Projects (LOPP) for funding for construction.

In order to integrate WBN needs and cost feasible WBN projects identified in the Go2040 LRTP, to analyze gaps in pedestrian systems, and to apply project prioritization methodology to consider grant applications, periodic St. Lucie WBN Update were established in the Unified Planning Work Program (UPWP).

The St. Lucie Walk-Bike Network update includes an inventory of projects that have been included on the LOPP as well as other projects identified as needs by the TPO and the municipalities.

### **ANALYSIS**


Geographic information about pedestrian and bicycle facilities is maintained and updated by the TPO and local agencies. The TPO gathers the geographic information from the local agencies, updates the WBN with the LOPP as well as other projects identified by the TPO and the municipalities.

In addition, TPO staff performs observation analysis via desktop (satellite), in the field, and with drone flights to verify and document progress during the construction phase of WBN projects. The WBN update indicates that the WBN increased by 48 miles of facilities constructed during 2014-2018. In addition, the WBN currently has 35 miles of projects funded for construction between 2018 and 2023.

It is recommended that the St. Lucie Walk–Bike Network Map be reviewed and input be provided regarding additions and deletions to the map.

#### **BACKGROUND**

At prior TPO Board meetings, Board members requested that the Board consider the recognition of TPO Priority Projects which received local funding or are removed from the TPO's List of Priority Projects (LOPP) because the projects have been funded completely by the local agencies.

Because the allocation of local funding to TPO Priority Projects advances the construction of TPO Priority Projects and allows the TPO's funding to be used for additional Priority Projects, it appears to be appropriate to recognize and incentivize the allocation of local funding to TPO Priority Projects. Therefore, the LIPPA is proposed to recognize the allocation of local funding and advance the construction of more TPO Priority Projects through incentives.

The TPO Advisory Committees are requested to review the proposed LIPPA and provide comments regarding its potential effectiveness in recognizing and incentivizing the allocation of local funding and advancing the construction of TPO Priority Projects.

## <u>ANALYSIS</u>

The proposed LIPPA would serve as an overlay to the various project prioritization methodologies employed during the annual development of the LOPP. A new column identified as "Local Funding Credits (LFCs)" is proposed to be added to each of the lists of the LOPP. Local funding allocated to a project in the LOPP will be denoted in the LFCs column. The corresponding recognition and incentive awarded by the LFC will vary according to the list.

For the projects in the Master List, it is proposed for the LIPPA to recognize and incentivize local funding contributed to projects in the list. One LFC will be awarded for every dollar of local funding allocated, as identified in the TPO's Transportation Improvement Program, to a project in this list. The projects will be reprioritized annually based on the quantity of LFCs awarded from highest quantity to lowest quantity. If there are ties in the number of LFCs among two or more projects, the order among those projects would remain the same as the previous year. Actual examples of the Master List before and after the application of the LIPPA are attached.

Because the projects in the Congestion Management Process (CMP) and Transportation Alternatives (TA) Lists are much less costly than the projects in the Master List, it is more likely for these projects to be fully funded by a local agency. Therefore, it is proposed for the LIPPA to recognize and incentivize those projects that are fully funded by a local agency. If a project in either one of these lists is fully funded by a local agency, the local agency will be awarded one LFC for every dollar of that project cost, and accordingly, that project will be removed from the list. The local agency then will be provided the opportunity to select another project from the list, the project cost of which is equal to or less than the quantity of LFCs awarded to the local agency, and the selected project will be advanced to the top of the list. If there are multiple projects with LFCs in the list, the projects will be ranked starting at the top of the list based on the quantity of LFCs awarded from highest quantity to lowest quantity. Hypothetical examples of the CMP and TA Lists before and after the application of the LIPPA are attached.

Because the projects in the Transit List are funded wholly or in part by the Transit Municipal Service Taxing Unit (MSTU), which is supported by every property owner in St. Lucie County, it is proposed for the LIPPA to recognize and incentivize those projects that receive local funding other the funding derived from the Transit MSTU. To incentivize greater local investment in the transit system, it is proposed that every dollar of local funding, other than that derived from the Transit MSTU, contributed by a local agency to a project on the list be awarded three LFCs that the local agency can apply to a project of their choice from the Master List. Hypothetical examples of the Transit and Master Lists before and after the application of the LIPPA are attached.

### **RECOMMENDATION**

It is recommended that the proposed LIPPA be reviewed and comments be provided to Staff.
